RESOLUTION 2023 - 210 ~ ADOPT LOCAL LAW INTRODUCTORY NO. "H" LAW WITH REGARD TO AMENDING SECTION 200-15 OF THE NORTHPORT VILLAGE CODE REGARDING THE USE OF HOME AND YARD MAINTENANCE EQUIPMENT

**WHEREAS,** The Village Board of Trustees held a public hearing on the 3<sup>rd</sup> day of October, 2023 at 6:00p.m. at 224 Main Street, Northport NY 11768 to consider amending Village Code Section 200-15 of the Northport Village Code regarding the use of Home and yard maintenance equipment and

**WHEREAS**, the code amendment is a Type II action pursuant to 6 N.Y.C.R.R. §617.5(c) 26 and, therefore, no further SEQRA review is required.

BE IT RESOLVED, The Board of Trustees desires to amend the Village Code

Section 200-15 entitled Construction activities, and hereby proposes the following local law

Local Law Introductory No. "8" as follows:

BE IT ENACTED BY THE VILLAGE BOARD OF THE VILLAGE OF NORTHPORT CONSIDERS AMENDING VILLAGE LAW CHAPTER 200-15, AS FOLLOWS:

#### §200-15. Construction Activities.

No person shall conduct, cause or permit to be conducted construction activities in a manner so as to produce a sound level exceeding the limitations in this section.

#### A. Residential Zoned Districts.

- (1) During the hours of 8:00 a.m. to 6:00 p.m., noise levels from a construction site shall not exceed an  $L_{10}$  of 80 db(A)s when measured at a distance 400 feet from the construction site.
- (2) During the hours of 6:00 p.m. to 8:00 am, noise levels shall not exceed an  $L_{10}$  of 70 db(A)s when measured at a distance of 400 feet from the construction site.

#### B. Fuel Powered Home and Yard Maintenance Equipment.

- (1) The operation of any Fuel Powered Home and Yard Maintenance Equipment during the following days and times shall be deemed a noise disturbance:
  - (a) Monday through Friday prior to 8:00 a.m. or after 6:00 p.m.; or
  - (b) Saturdays between Memorial Day and Labor Day; on Saturdays prior to 9:00 a.m. or after 5:00 p.m. during the remainder of the calendar year; or
    - (c) Sunday or Holidays.

Notwithstanding the above, Fuel Powered Home and Yard Maintenance Equipment may be used on Saturdays, Sundays or Holidays between 9:00 a.m. and 5:00 p.m. as set forth below and not be deemed a noise disturbance:

- (1) use by property owners; or
- (2) use by governmental entities; or
- (3) use by commercial landscapers performing commercial landscaping services at cemeteries, government properties and public school-owned properties, or in

#### commercial and industrial zones.

- (2) All fuel-powered equipment shall only be operated for two (2) hours of use per property on weekdays, and if permitted as set forth above, one (1) hour of use per property on Saturdays, Sundays or holidays. These time restrictions shall not apply to spring clean-ups (March 15<sup>th</sup> through April 30<sup>th</sup> each calendar year) or fall clean-ups (November 1<sup>st</sup> through December 20<sup>th</sup> each calendar year.
- (3) In the event of an emergency as determined by Village Administrator, or the Village Administrator designee, the restrictions set forth herein may be suspended.

On the motion of Trustee Sabia and seconded by Trustee Dolan, the following resolution was unanimously approved.

### RESOLUTION 2023 – 211 ~ PART TIME CALL-IN FIRE DEPARTMENT DISPATCHER

**WHEREAS**, Anthony Martin has applied for the position of part-time call-in dispatcher for the Village of Northport Fire Department and

**WHEREAS**, hiring of employees is a Type II action pursuant to 6 N.Y.C.R.R. Section 617.5(c)(26), and, therefore no further SEQRA review is required.

**BE IT RESOLVED,** Anthony Martin is hereby hired for the position of part-time call-in dispatcher for the Village of Northport Fire Department, and as with all applicants, Anthony Martin will be subject to a background check.

**BE IT FURTHER RESOLVED,** Anthony Martin will work no more than 17.5 hours a week at a rate of pay of \$29.49 per hour.

**BE IT RESOLVED,** Samantha Eisner is hereby hired for the position of Paramedic for the Incorporated Village of Northport, and as with all applicants, Samantha Eisner will be subject to a background check and confirmation of all certifications necessary to hold the position of Paramedic, and

**BE IT FURTHER RESOLVED,** Paramedic Samantha Eisner will work no more than 17.5 hours a week at a rate of pay of \$32.00 per hour.

#### **RESOLUTION 2023 - 213 ~ PART-TIME PUBLIC SAFETY DISPATCHER**

**WHEREAS,** Due to the pending retirement of a Public Safety Dispatcher, the Northport Police Department is in need of a replacement;

**WHEREAS,** the offer of employment to the Northport Village Police Department is a Type II Action pursuant to 6 N.Y.C.R.R. Section 617.5(c)(26) and, therefore no further SEQRA review is required.

**BE IT RESOLVED,** That Sean Sheridan, an eligible candidate as certified by the Suffolk County Department of Civil Service, is hereby hired as a part-time Public Safety Dispatcher at an hourly rate of \$36.34/per hour, effective immediately.

## RESOLUTION 2023 – 214 ~ TO ACCEPT PROPOSAL FOR TEST PITS REQUIRED TO CONTINUE SANITARY SEWER COLLECTION SYSTEM EXTENSION, STEERS PIT AREA

**WHEREAS,** in response to a request by the Village Administrator, a quote was received for exploratory work for sanitary sewer expansion, located Steers Pit Area which has been confirmed to be required by J. R. Holzmacher Engineers.

WHEREAS, a proposal was received August 9th, 2023 at Northport Village Hall from ADJO Contracting Corp. located at 207 Knickerbocker Avenue, Bohemia, NY 11716, with an amount of \$18,800, based on the Suffolk County Contract #SSAIR102221P, this expenditure will be recorded as a portion of the required matching funds and will be applied towards the \$5,000,000.00 WQIP grant.

WHEREAS, ADJO Contracting was provided with the plans and specifications, a type II action pursuant to 6 N.Y.C.R.R. Section 617.5 (c)31 and is not subject to any further action under SEQRA

**BE IT RESOLVED,** The Mayor is hereby authorized and directed to execute any necessary contracts with ADJO Contracting Corp. for the excavation and restoration including all materials necessary for exploratory work related to the Sanitary Sewer Collection System Extension, Steers Pit Area.

#### RESOLUTION 2023 - 215 ~ PAYMENT OF SMALL CLAIMS ASSESSMENT REVIEW

**WHEREAS**, the property identified as 16 James Street (SCTM# 0404-6-2-1.3) commenced small claims assessment reviewing proceedings (SCAR) claiming that the subject property was over assessed for the 2021/2022 tax years at values which exceeded the true value of the property; and

**BE IT RESOLVED**, that the Village Treasurer is hereby authorized to pay a refund of \$1,145.08 to Tax Crushers, the property owners' representative for the premise identified, as determined to be due by the Village Assessor.

# RESOLUTION 2023 – 216 ~ REIMBURSEMENT TO 7 BLUFF POINT ROAD FOR NECESSARY CONSTRUCTION REQUIRED TO CONNECT INTO THE SANITARY SEWER COLLECTION SYSTEM

**WHEREAS,** a request made by Rene Fiechter of 7 Bluff Point Road, for reimbursement of \$3,700. for expenditures in preparation for connection to new Bluff Point Road Sanitary Sewer System and

**WHEREAS**, expenditure will be recorded as a portion of the required matching funds and will be applied towards the \$5,000,000.00 WQIP grant and,

**WHEREAS,** this is type II action pursuant to 6 NYCRR Section 617.5 (c)31 and is not subject to any further action under SEQRA.

**BE IT RESOLVED,** The Mayor is hereby authorized and directed to authorize the release of funds related to the reimbursement of this expenditure for connection to the Sanitary Sewer Collection System.
