BE IT RESOLVED, The Mayor is hereby authorized to execute any necessary contracts with Brandt Marine Inc. for the supply and installation of all materials necessary for repair/replacement of the Main Street Pier (Phase II).

WHEREAS, in response to a notice placed by the Village Clerk, RFP's and bid documents were issued for the installation of the Denitrification Filter No. 4 at the Village Wastewater Treatment Plant located at 1 Ketcham Place, which has been confirmed to be required by J.R. Holzmacher P.E., LLC and

WHEREAS, (4) Sealed bids were received on February 28th, 2024 at Northport Village Hall and based on the review of these bids by J.R. Holzmacher P.E., LLC, the lowest responsible bidder was R.J. Industries, Inc., located at 75 East Bethpage Road, Plainview, NY 11803, with a bid for \$224,700.00 and

BE IT RESOLVED, The Mayor is hereby authorized to execute any necessary contracts with R.J. Industries, Inc. for the installation of Denitrification Filter No. 4 equipment and all necessary components.

RESOLUTION 2024 - 39 ~ AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE NEW YORK SEA GRANT INSTITUTE TO DEVELOP AND SUBMIT A GRANT PROPOSAL FOR THE PURCHASE OF A PUMP-OUT VESSEL

WHEREAS, the Village of Northport desires to submit a grant request and proposal to NYS CFA - DEC's water quality Improvement project, and

WHEREAS, there is no cost to the Village of Northport as New York Sea Grant will enter into an agreement with GEI Consultants, Inc., P.C. to assist the Village of Northport with the Grant request and proposal,

WHEREAS, entering into an agreement to submit a grant request is not an action pursuant to SEQRA,

NOW THEREFORE BE IT RESOLVED, the Mayor is authorized to enter into an agreement with New York Sea Grant for purposes of working with GEI Consultants, Inc., P.C. to submit the grant request for assistance in purchasing a sanitary pump-out vessel to improve water quality in Northport Harbor the Village of Northport.

RESOLUTION 2024 - 40 ~ AUTHORIZING THE MAYOR TO EXECUTE AN IPS GROUP CUSTOMER AGREEMENT FOR THE PURCHASE OF PARKING TECHNOLOGY AND RELATED SERVICES

WHEREAS, The Village of Northport seeks to improve downtown public parking technology and services on Main Street and at the west end of Northport Village; and

WHEREAS, the agreement will include two hundred and twenty-five Model MK5 895 single-space meters and sensors (215 installed & 10 spares); and

WHEREAS, the agreement will include the IPS GROUP - Park Smarter mobile app. for greater efficiency and a real-time web-based data management system application; and

WHEREAS, the agreement will include IPS GROUP client support to the Village at all levels of administration for public parking technology and services; and

WHEREAS, a "Sole Source" vendor IPS GROUP at 7737 Kenamar Court, San Diego, CA 92121 has been selected for the purchase of (225) single-space meters and sensors as per the agreement specifications at a cost not to exceed \$257,835.75

WHEREAS, the purchase of parking technology and related services is a Type II action pursuant to 6 N.Y.C.R.R. §617.5(c) (26) and therefore no further SEQRA review is required.

NOW, THEREFORE BE IT RESOLVED, the Mayor is hereby authorized to execute an agreement with IPS GROUP for the purchase of parking technology and related services in the amount of \$257,835.75 and further authorizes the mayor or her designee to enforce the provisions of the agreement and all other relevant documents as deemed necessary by the Village Attorney.
