RESOLUTION 2024 - 43 ~ OFFER OF EMPLOYMENT TO PUBLIC SAFETY DISPATCHER

WHEREAS, The Northport Police Department is in need of a replacement for a vacant Public Safety Dispatcher Position;

WHEREAS, after deliberation and due diligence and upon the recommendation of Chief Hughes;

BE IT RESOLVED, That the Village Board of Trustees hereby authorizes an offer of employment to Jonathan Torres who has been certified by Suffolk County Civil Service and the Suffolk County Police Department applicant investigation unit to the position of Public Safety Dispatcher, and that upon completion of a background investigation, Jonathan Torres shall receive all compensation and benefits associated with said position pursuant to the agreement between the Village and the Local 342 effective on or about March 21, 2024.

WHEREAS, The Board of Trustees authorizes the purchase of a Westerbeke 7.5 MCGA Generator including 30' Wiring Harness, remote start/stop panel and controls from Hansen Marine Engineering, 32 Tioga Way, Marblehead, MA and

WHEREAS, the village has solicited (5) written comparative quotes and the lowest qualified quotation with immediate availability was submitted by Hansen Marine Engineering Inc. and

WHEREAS, the purchase amount shall not exceed \$18,500.00, vendor requested wire transfer or certified check upon placement of order and

WHEREAS, such appropriation shall be made from the 2023-2024 budget and BE IT RESOLVED, the treasurer is authorized to make all necessary budget adjustments.

RESOLVED, That a public hearing will be held before the Village Board of Trustees, at Northport Village Hall, 224 Main Street, Northport, NY 11768, on April 16, 2024, at 6:00 PM, or as soon thereafter as practicable, to consider the condemnation of real property known as Suffolk County Tax Map District 0404 Section 009.00 Block 02.00 Lot 085.001, consisting of approximately 20,107.78+ square feet, or 0.462 + acres, commonly known as Ackerly Terrace, Northport, NY 11768 ("Subject Property"), for the public purpose of providing ingress and egress over the Subject Property to access those properties located proximate to the Subject Property, including to the public and the owners of property adjacent to the Subject Property, prior to any acquisition of the Subject Property; and be it further

RESOLVED, That the Village Clerk shall publish a notice of the said Village Board of Trustees meeting and hearing in the newspaper(s) of general circulation in the Village of Northport pursuant to the provisions of the law.

BE IT RESOLVED, Quinlan Finnegan is hereby hired for the seasonal position of Highway/Parks Department worker for the Incorporated Village of Northport.

BE IT FURTHER RESOLVED, Quinlan Finnegan will work no more than 40 hours a week at a rate of pay of \$18.00 per hour, from April 1st till September 30th and FURTHER RESOLVED, this is an unlisted Action pursuant to 6 N.Y.C.R.R. Section 617.5(c)(26), and, therefore, no further SEQRA review is required.

RESOLUTION: 2024 - 50 ~ PURCHASE OF BACKHOE

WHEREAS, The Village Board hereby authorized the purchase of a new 2023 Caterpillar Backhoe Loader Model 450-07ESTK from H.O. Penn Inc., NYS Contract #PC69406 as per Quote #135985-01 in the amount of \$237,455.00, and

WHEREAS, The Village Board hereby accepts the trade-in value for the 2018 Caterpillar Model #430F2 IT, of \$58,000.00, and

WHEREAS, The Village Board hereby authorized the appropriation of Fund Balance not to exceed \$30,000.00 and authorizes allocation of the current years CHIPs Grant funding in the amount of \$150,000.00 to the purchase of this vehicle, now therefore

BE IT RESOLVED, That the Village Board hereby authorizes the reallocation of CHIPS funding in the amount of \$150,000.00 for the Caterpillar Backhoe Loader Model 450-07ESTK from CHIPS funding in the 2024-2025 fiscal year, and accepts the trade-in amount of \$58,000.00, and

FURTHER RESOLVED, this is an unlisted Action pursuant to 6 N.Y.C.R.R. Section 617.5(c)(31), and, therefore, no further SEQRA review is required.
