RESOLUTION 2025 – 104 – TO ACCEPT BID AND AUTHORIZING THE AWARD OF CONTRACT FOR NEW SANITARY SEWER COLLECTION SYSTEM EXTENSION, PHASE II, STEERS PIT AREA

WHEREAS, in response to a notice placed by the Village Clerk, bid documents were issued for the sanitary sewer expansion, Phase II, Steers Pit area, which have been confirmed to be required by J. R. Holzmacher Engineers, and

WHEREAS, four (4) sealed bids were received on June 16th, 2025, at Northport Village Hall, and based on the review by J. R. Holzmacher, the lowest responsible bidder was ADJO Contracting Corp. located at 207 Knickerbocker Avenue, Bohemia, NY 11716, with a bid for \$2,197,515.50, and

WHEREAS, Bidders were provided with the plans and specifications and this is a type II action pursuant to 6 NYCRR Section 617.5 (c)31 and not subject to any further action under SEQRA.

NOW THEREFORE BE IT RESOLVED, The Mayor is hereby authorized and directed to execute any necessary contracts with ADJO Contracting Corp. for the supply and installation of all materials necessary for Sanitary Sewer Collection System Extension, Phase II, Steers Pit Area, and all other relevant documents as deemed necessary by the Village Attorney.

RESOLUTION 2025 - 105 ~ AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT FOR MAINTENANCE OF HVAC MECHANICAL EQUIPMENT LOCATED AT NORTHPORT FIRE STATION #1

WHEREAS, the maintenance, inspection and repair of the mechanical system that services Northport Fire Station #1 are required in order to facilitate efficiency of the system and prolong the life expectancy of the equipment; and

WHEREAS, this is a specialized technical service, for the maintenance, inspection and repair of the HVAC mechanical system; and

WHEREAS, Inter-County Mechanical Corp., 1600 Ocean Ave, Bohemia, NY 11716, at a cost of Fifteen Hundred and Thirty-nine Dollars (\$1,539.00) for a one-year contract for the maintenance of the HVAC mechanical system, and that Inter-County Mechanical Corp. has the technical familiarity and the fastest response time for servicing the system which is of critical importance to the Village; and

WHEREAS, the HVAC maintenance contract is a Type II action pursuant to 6 NYCRR §617.5(c) (26) and therefore no further SEQRA review is required.

NOW, THEREFORE BE IT RESOLVED, the Mayor is hereby authorized to execute a contract with Inter-County Mechanical Service Corp. for the maintenance of the HVAC system servicing Northport Fire Station #1, at 22 Waterside Road, Northport, NY, in the amount of \$1,539.00, and further authorizes the mayor and/or her designee to enforce the provisions of the contract, and all other relevant documents as deemed necessary by the Village Attorney.
