WHEREAS, in response to a Notice placed by the Village Clerk, bid documents were issued for the creation of a Local Waterfront Revitalization Program and Harbor Management Plan, and

WHEREAS, (3) Sealed bids were received on May 16, 2025 at Northport Village Hall. Based on the review by the Waterfront Advisory Committee, the lowest qualified bidder is H2M Architect and Engineers, 538 Broadhollow Road, Melville, NY, with a bid for \$135,000.00 and

WHEREAS, Bidders were provided with a detailed request for proposal which is a Type II action pursuant to 6 N.Y.C.R.R. §617.5 (c)31 and is not subject to any further action under SEQRA.
