RESOLUTION 2025 – 167 ~ AUTHORIZING THE PURCHASE OF A PIERCE ENFORCER RESCUE PUMPER FOR THE NORTHPORT FIRE DEPARTMENT

WHEREAS, the Northport Fire Department has identified the need to replace existing apparatus to maintain the safety and efficiency of fire and rescue operations; and

WHEREAS, Firematic Supply Company, Inc. has submitted a proposal dated October 13, 2025, for the furnishing of one (1) Pierce Enforcer Rescue Pumper as per Specification #977, including delivery, insurance, inspection trips for eight (8) members, and tool mounting, for a total cost of One Million Three Hundred Seventy-Five Thousand Dollars (\$1,375,000.00); and

WHEREAS, said proposal conforms to applicable Federal Department of Transportation (DOT) rules and regulations and National Fire Protection Association (NFPA) standards for automotive fire apparatus; and

WHEREAS, the Village Board of Trustees finds it to be in the best interest of the Village of Northport and its residents to authorize the purchase of said apparatus; and

WHEREAS, the expected delivery timeline for the Pierce Enforcer Rescue Pumper is approximately 1,620 working days from the date of order; and

WHEREAS, this action is a Type II action pursuant to 6 N.Y.C.R.R. §617.5(c)(25) and **therefore** no further SEQRA review is required;

NOW, THEREFORE, BE IT RESOLVED, That the Board of Trustees of the Incorporated Village of Northport hereby accepts the proposal of Firematic Supply Company, Inc. for the purchase of one (1) Pierce Enforcer Rescue Pumper, as per Specification #977, in the amount of \$1,375,000.00; and

BE IT FURTHER RESOLVED, That the Mayor is hereby authorized to execute all necessary documents and agreements with Firematic Supply Company, Inc. to effectuate said purchase, subject to review and approval by the Village Attorney; and

RESOLUTION 2025 - 172 \sim AUTHORIZING THE PURCHASE FOR REPLACEMENT OF BOOM TRUCK ARM

WHEREAS, the purchase of a boom truck arm to replace the broken part is required to operate the boom truck safely; and

WHEREAS, this is a specialized Altec replacement part from Altec Parts Inc., 5610 Corporate Drive, St. Joseph, MO 64507; and

WHEREAS, the cost will not exceed Six Thousand Dollars (\$6,000) for the specialized replacement equipment, an Altec truck part, this equipment is of critical importance to the Village; and

WHEREAS, the replacement part purchase is a Type II action pursuant to 6 N.Y.C.R.R. §617.5(c) (26) and therefore no further SEQRA review is required.

NOW, THEREFORE BE IT RESOLVED, the Village Administrator is hereby authorized to purchase a replacement part from Altec Parts Inc., 5610 Corporate Drive, St. Joseph, MO 64507 in the amount not to exceed \$6,000.00, and further authorizes the Treasurer's office to make advanced payment and necessary fund transfers.

RESOLUTION 2025 – 173 ~ APPROVING THE MAYOR TO ENTER INTO AN AGREEMENT TO COLLECT FEES TO COVER THE COST OF PROVIDING EMS SERVICES FOR THE RESIDENTS OF THE INC. VILLAGE OF NORTHPORT

WHEREAS, the Northport Fire Department/Inc. Village of Northport is responsible for providing fire, ambulance, and emergency services protection within the area of the Department located within the Village of Northport, Suffolk County, New York; and

WHEREAS, the Fire Department/Village organizes and maintains a volunteer fire department, trained emergency medical services personnel, and proper firefighting and emergency medical services equipment for the fighting of fires and protection of life and property in case of fire, accident, act of God, or other emergencies, and

WHEREAS, the Fire Department is duly authorized by the Inc. Village of Northport and New York State Law and has conducted the require vote approved by the required number of members approving the charging for EMS services, and

WHEREAS, through the operations of the Fire Department and Village employees, provides emergency medical services to the residents of the Village; and

WHEREAS, the cost of providing such services represents a significant portion of the Fire Department and Village's annual budget; and

WHEREAS, the State of New York, has recently permitted Fire Departments, at their option, to charge fees for EMS services (General Municipal Law § 209-b); and

WHEREAS, said law requires that when fees and charges are to be authorized, they "shall be disbursed in accordance with a written contract entered into between" the Village and the Fire Department; and

WHEREAS, the Inc. Village of Northport has determined that it would be beneficial to the taxpayers of the Village to charge fees for EMS services in accordance with law:

NOW, THEREFORE, in consideration of the mutual covenants herein contained, and by virtue of the power and authority conferred by the laws of the State of New York, the parties hereto agree as follows:

FIRST: Inc. Village of Northport shall, at its earliest convenience, commence charging for EMS services in a manner which is compliant with law.

SECOND: Upon the commencement of receipt of fees for EMS services the Village shall keep a separate account of all such fees collected, along with the costs of fee collection.

THIRD: The Village shall, on an annual basis, review the amount of net fees collected and endeavor to use such fees as follows: To improve the provision of EMS services to the community by the purchase of equipment and the payment of salaries and for training. The Village shall make such determinations as part of its annual budget preparation, but shall not be bound by any particular formula.

FOURTH: The Fire Department agrees and consents to the use of fees and charges as set forth above.

FIFTH: The term of this agreement shall be for five (5) years and shall be extended for additional five (5) year terms unless either party hereto shall file a written objection with the 2 others at least six (6) months before the end of a term.

SIXTH: No amendment of this agreement shall be effective unless in writing and duly

executed by the parties hereto, their successors, or duly authorized officers. SEVENTH: Any and all notices required or contemplated under this contract shall be made, in writing, by either first-class mail or overnight delivery, to the parties at the addresses set forth above.

IN WITNESS WHEREOF, the Mayor is authorized by the Board of Trustees, the Board of Fire Commissioners; and by the membership of the Northport Fire Department, to enter into an agreement with a third-party vendor to collect fees for EMS Services.
