FILE 20-17 - RITE AID - 75 MAIN ST.

Nick Maringelli on behalf of Rite Aid Corp. came before the board to request permission to change the sign at 395 Ft Salonga Rd. The new sign will replace an existing sign above the doorway entrance on the center of the building. The doorway sign text will change to green and blue. The sign will also include the new Rite Aid crest to the left of the text. The directory sign will also be replaced. This sign text will change to green and blue to match the sign on the building, it will also include the Rite Aid crest and "pharmacy." Both signs will be illuminated. The board had asked Mr. Maringelli to make some adjustment and report back to the board in October.

FILE 20- 18- TD BANK - 647 MAIN ST.

Arlene Meli on behalf of Ultimate Signs & Design Corp. for TD Bank appeared before the board to request permission to change the signs at 647 Main St. The new signs will be replacing existing signs just updating to TD Bank's new color and font specs. The entrance channel letters "TD" will be updated to a new shade of green the white lettering will not change and there will be no updates to the illumination or size of the sign. The side TD wall cabinet will be a face replacement to a lighter shade of green. There will be no change to illumination or size. The illuminated directional signs will be updated to a slimmer non-illuminated sign with same messaging and reflective white vinyl copy.
