RESOLUTION 2025 - 1 ~ APPROVAL OF MINUTES

BE IT RESOLVED, the minutes of the December 17, 2024 meeting are hereby accepted.

RESOLUTION 2025 - 2 ~ APPOINTMENT OF CHIEF OF POLICE

WHEREAS, Chief of Police Christopher Hughes will retire from the Northport Police Department effective on or about 11:59 PM March 28, 2025, and

WHEREAS, Alan Bakker has served as Lieutenant of the Northport Police Department, and

NOW, THEREFORE, BE IT RESOLVED, that Alan Bakker is hereby granted the permanent appointment subject to certification from Suffolk County Civil Service, to the Office of Chief of Police of the Northport Police Department effective at midnight March 28, 2025, and

FURTHER RESOLVED, the Mayor is hereby authorized to execute an employment agreement with Alan Bakker and the Village affecting his engagement as Chief of Police of the Northport Police Department with terms and provisions as approved by the Village Board of Trustees and subject to approval as to form and content by the Village Attorney, and

FURTHER RESOLVED, The Treasurer is authorized to pay Lt. Alan Bakker past service accrued time upon promotion to the rank of Chief.

RESOLUTION 2025 – 3 ~ FULL-TIME COURT CLERK

BE IT RESOLVED, Part-Time Court Clerk Carolanne Darrigo is hereby appointed to the position of Full-Time Court Clerk of the Village Court effective March 3, 2025 at an annual salary of \$55,000.00 plus a \$125.00 stipend per Monday night court session. RESOLUTION 2025 – 4 ~ PART-TIME CALL-IN FIRE DEPARTMENT DISPATCHER

WHEREAS, Ryan Kleinkopf is currently employed with the Village of Northport as a part-time Fire Marshal and in addition has applied to become a per diem part-time call-in dispatcher for the Village of Northport Fire Department,

WHEREAS, hiring of employees is a Type II action pursuant to 6 N.Y.C.R.R. Section 617.5(c)(26), and, therefore no further SEQRA review is required.

NOW, THEREFORE, BE IT RESOLVED, Ryan Kleinkopf is hereby hired for emergency backup to support the Incorporated Village of Northport Fire Department as a per diem part-time call-in dispatcher, and

RESOLUTION 2025 – 6 ~ AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE SUFFOLK COUNTY DIVISION OF BUDGET FOR AN ANNUAL REVENUE SHARING PAYMENT FROM THE COUNTY
